#### III. Approval of Meeting Minutes

Minutes for the August 7, 2019 meeting presented to Board Members were approved unanimously.

# IV. Old Business

A. **Approval of Bylaws:** Jennifer provided an overview of the revisions made to the Developmentally Disabled Advisory Board bylaws in order to comply with the Open Meetings Act (OMA).

In section 4-1 Mike Bibo asked if the department could consider changing the number of board members required to meet a quorum from six to five board members. Mike Bibo asked if the department would consider the total number of members needed to meet a

quorum be based on the number of current advisory board members present at the meeting.

Jennifer Uhles explained that the Illinois Open Meetings Act (OMA) requires six voting members to reach a quorum. In order to change the Advisory Board quorum requirements, the statutory act would have to be amended in order to enact that change in the bylaws.

In section 4-8 the board members said that the department should inform all attendees of the meeting recording disclosure.

In section 5-1 Mike Bibo said that the bylaws should include MCDD facilities under Article V responsibilities pertaining to rule making.

A. **Confirmation of Meeting Dates (2020/2021):** The advisory board members approved the board meeting dates for the 2020 calendar year unanimously.
