MINUTES

1. Welcome to Guests and Introductions

Robin L. Jones, MD

Robin Jones, MD welcomed members to the meeting and welcomed members.

2. MMRC Case Reviews and Recommendations

All

Pat Prentice moved that the meeting be closed at 9:20 am. Seconded by Trish O'Malley. The meeting was re-opened at 1145 with a motion from Deborah Boyle, seconded by Joan Briller.

3. Review and Approval of Minutes- December 9, 2015

All

The minutes of the December 9, 2015 meeting were reviewed. Nancy Martin moved approval, Stacie Geller seconded. The minutes were approved unanimously.

4. Call for Emergency Room Physician Nominations

All

A discussion was held regarding the need for an emergency room physician to be on the MMRC especially in light of the ILPQC Statewide Hypertension Project. A motion was made and

approved unanimously to include and ER MD on the MMRC. Please send CV's and description of nominee to Pat Prentice.

5. Detecting and Preventing Heart Disease Joan Briller, MD

Dr Briller presented a Lecture regarding Pregnancy and Subsequent Cardiac risk. The material reflected studies as well as plans of care for the pregnant patient with cardiac disease. The members voiced their gratitude for this information as so many maternal death cases now have major cardiac factors.

Robin Jones requested that the MMRC create a group to develop recommendations for the care of pregnant cardiac patients. Deborah Boyle discussed proper screening to be linked to Medicaid contracts. Dr Loew discusses the absence of interconceptional care coverage for Medicaid patients

6. OBHEP Update.....Shirley Scott, MS, RNC, APN

Members were informed that the Illinois Holocaust Museum has requested an exhibit on Maternal death for the Museum to run from September 2016 through January 2017.

8. Update on Severe Maternal Mortality Data.....Abby Koch/Stacie Geller, Ph.D

A report on the trial of the SMM form was given with the intent that the form will be used on all ICU admissions and on selected OB Hemorrhages with 4 or more units of packed red blood cells administrators. The effective date for all hospitals is July 1, 2016

9 IDPH Report Andrea Palmer, MPA, MBA, CHSM

Future plans for an MMRC database approved by the CDC were discussed. The database is being piloted in Ohio, Colorado, Georgia and Delaware. The database will allow us to create accurate data much faster. The database will contain elements for an abstract and disposition and will include a statement of impact that the case may provide.
